Your schedule must provide all the information required by law for a Bill of Discharge (as set out in Article 175 of Commission Delegated Regulation 2446/2015 and Article 265 Commission Implementing Regulations 2447/2015) and be in a format that is readable and understandable to HMRC. The minimum font size of any attachments to the BoD should be 8.
